## ARNEC crafts response strategy to COVID-19; amplifies ECD learning, advocacy for young children, families during pandemic



After issuing a statement on the pandemic and how it affects young children and their families (see next page), ARNEC immediately developed a response strategy containing priority measures raising the role of ECD and targeting the needs of young children and their families and caregivers in the Asia-Pacific region.

This ARNEC document was triggered by the adverse impacts of the pandemic on young children, as a result of governments' mitigation

measures to contain the geographic spread of the COVID-19 virus, particularly closure of pre-schools, ECD centres, and schools, and imposing the stay-at-home policy. The same document prioritises urgent learning and advocacy measures to promote the social-emotional well-being of young children and their families.

Among the ARNEC strategies include holding regular webinars for the ECD community and initiating a survey generating the perspectives of the ECD community in the region on the state of young children and status of ECD in their respective countries. Both are nearing completion, findings of which will be shared in the ARNEC website soon.

The ARNEC COVID-19 response strategies have given emphasis to the priority needs of young children living with poor families and migrant workers, as well as those who might be excluded on the basis of gender, ethnicity, location, language, and/or faith, among others.

## ARNEC on pandemic: protection, well-being of young children first

**ARNEC has issued a statement in March 2020 calling on multi-sectoral effort amplifying critical role of ECD in responding to COVID-19; excerpts below**

ARNEC stands for the protection and wellbeing of young children and their families and communities, as governments work with all sectors of society to contain the spread of COVID-19 in countries in the Asia-Pacific region and the rest of the world.

ARNEC strongly supports multi-sectoral and whole-of-society measures to halt the geographical spread of the COVID-19 virus and to address unintentional impacts on young children, such as school closures, pressures on national and local health systems, squeeze on public and private investments, and financial and economic downtrend.

ARNEC is concerned on the overall burden placed on the family, especially the poor, as a result of prolonged days of non-work, the concomitant effects on household incomes, plus the adjustment measures it has to make in the face of a looming global slowdown.

## ARNEC webinars rated highest in importance, usefulness, learning

ARNEC has completed seven webinars since it launched its first on young children amidst COVID-19 on 13 April 2020. Two more webinars are being programmed before ARNEC wraps up the webinar series.

The seven webinars were conducted weekly featuring a key speaker, in addition to 2-3 practitioners sharing country-level ECD practices and showcasing diverse context-specific responses to the pandemic.

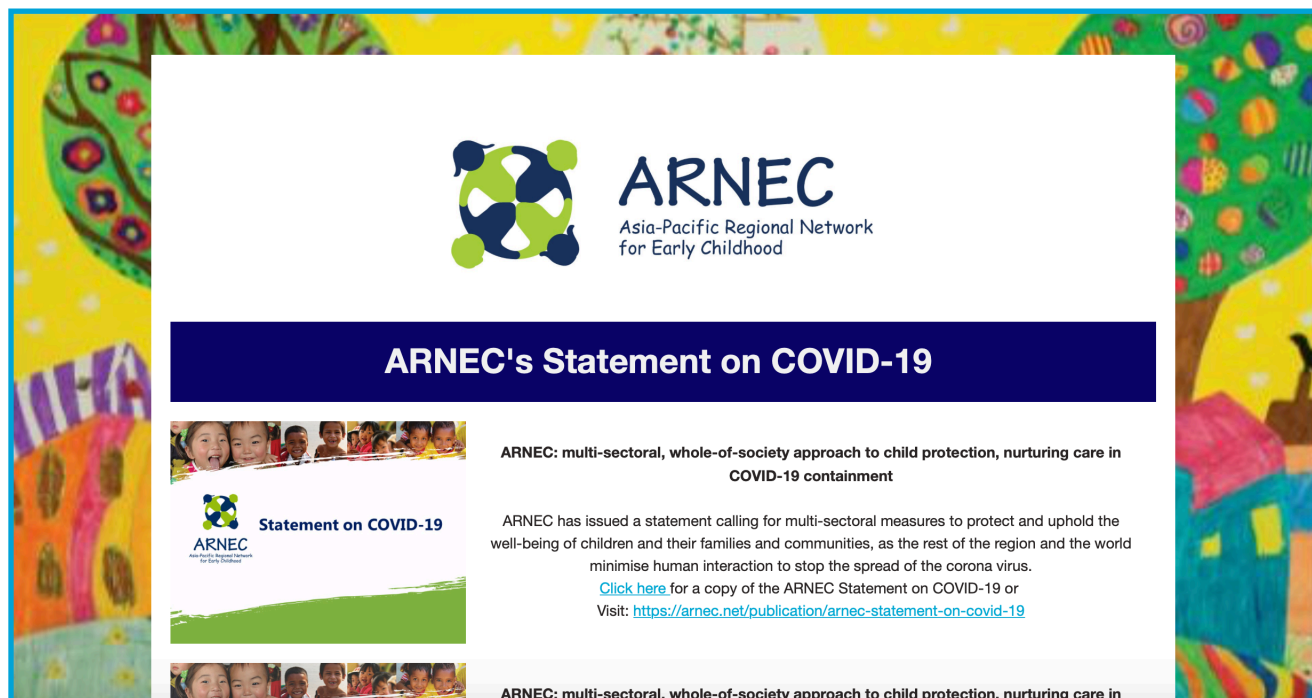

**Chencho Wangdi, Bhutan**

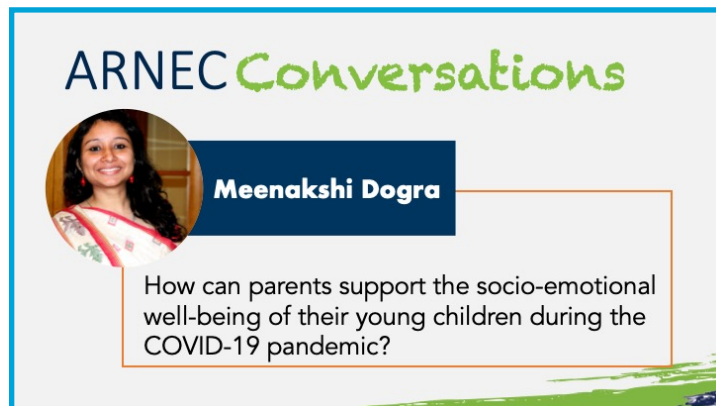

Mr. Chencho took an active role in scaling up the ECCD programme for the children age 3 to 5 years old in all districts and municipalities in Bhutan.

Along with strengthening the access to the ECCD programme access, he is instrumental in putting in place an effective monitoring mechanism to maintain the quality of the programme. Prior to his current post, he was a Human Resource Officer for the Ministry of Education until 2012. He joined Government Service in 2001 after



completing his studies in the field of education. He is currently serving ARNEC as a National Representative of Bhutan.
